PRESIDENT'S CORNER

Dear Twins,

As I write this, I am reflecting on our second virtual conference held in place of our annual inperson conference this year. I want to thank the Conference Planning Committee for putting on another great event this year: Wilmette Combs, Michelle Getchell, Venice Lacy, Judith Olson, Alyssa Pratt and Dena Stitt. This year we started the conference with a virtual auction held on our Facebook page in coordination with our Facebook Moderators, organized by Wilmette Combs. The auction netted \$785 for the organization. The Conference T-shirt fundraiser, organized by Venice Lacy, also netted \$725 for the organization. I also enjoyed the Virtual Memory Walk in the morning and seeing many familiar and new faces, some walking outside and some just standing or sitting. I want to thank the chair of the Memory Walk fundraiser, Margaret Daffin. Through her fundraising efforts and yours, we raised a total of \$6,930! These funds support our organization so that we can continue to exist to help twinless twins, as well as provide scholarships for twins in need for membership dues and conference registration fees.

We then held our Annual Business Meeting, where we voted in new Board members: Larry Adams, Eduardo Echeverria, Judith Olson, and Beverly Smyk and thanked outgoing board members, Margaret Daffin, Venice Lacy, Terry Lewis-Foor and Bob Osterholt. Also, at our Business Meeting, we announced the creation of the TTSGI Founders' Memorial Endowment Fund, which currently has pledges of over \$200,000. This Endowment Fund was made possible by the generosity of Mary Rockefeller Morgan. Mary chose to make an extraordinary financial gift to TTSGI of \$100,000 in order to make sure our organization would always exist for twins who lose their twin. You can learn more about the Endowment Fund in this newsletter.

Next, Dr. Joan Friedman provided a Keynote address on twin loss and answered questions from twins. I found the Q&A very valuable and I am sure that other twins have more clarity on why so many twins struggle with moving forward in their lives. I want to emphasize that Once a twin, Always a twin from early loss to recent loss of just two weeks ago, to know that you are not alone. Twins can heal by helping each other in our journeys to healing. We are strengthened as an organization by being a diverse community with different types of loss, backgrounds and lived experiences. Also, I believe our twins are always with us and I wear a bracelet every day that says "We are never far apart" to remind me of that. I liked Dr. Friedman's reminder that we can still talk to our twins each day and on those special occasions. As a reminder, the Keynote was taped and is included in the Member's Corner of the TTSGI website.

Then we had breakout groups to provide a safe space for twins to share and listen to one another as part of our journey to healing. Thank you to breakout group leaders, Venice Lacy, Alyssa Pratt, Paul Heiden, Ruth Selig, Ed Echeverria, Dena Stitt and Judith Olson. Finally, we finished with a panel Q&A discussion regarding twin loss from different "alumni" twins, including myself, Joan Angelis, Margaret Gron, Ray Boyle and Ed Echeverria, who have been on our healing journeys for a while.

I want to thank all the twins involved in planning and facilitating the day. Also, I want to thank our Executive Director Michelle Getchell and her husband Rick who facilitated the Zoom logistics for the virtual conference. I look forward to our next inperson conference in Denver 2022, but in the meantime, please take advantage of all the opportunities to gather virtually. I want to thank our Regional Coordinators, who are hosting both regional gatherings virtually and a series of specialized virtual meetings based on type of loss or other common factors. While I miss seeing you all in person, I am glad that we can continue to use technology to gather safely.

THE EMPTY CHAIR

THE CRACKED DIAMOND

There is an old Jewish folk story told in the 1700's that I often read in my grief groups. There is a lesson in this story that can help all of us find hope in the midst of our grief.

"Once upon a time there was a king who ruled a small kingdom. The king had a great perfect diamond that had been in the family for generations. He kept it on display for all to see and appreciate. People came from all over the country to admire and gaze at it. Word of it spread to neighboring countries, and more people came to look at it. Then one day a soldier came to the king with news that, although no one had touched the diamond, for it was guarded night and day, the diamond was cracked. The king ran to see and sure enough there was a crack right through the middle of the diamond. Immediately the king summoned all the jewelers of the land and had them look at the diamond. One after another examined it and gave the bad news to the king: the diamond was irredeemably flawed. The king was crushed. Then out of nowhere came an old man who claimed to be a jeweler. He asked to see the diamond. After examining it, he looked up and confidently told the king that he could fix it. The king was shocked and a bit leery. But the old man said to give him the jewel, and in a week, he'd bring it back. Now, the king was not about to let the stone out of his sight so he gave the old man a room, all the tools and food and drink he needed, and he waited. The whole kingdom

waited. It was a long week. At the end of the week, the old man appeared with the stone in his hand and gave it to the king. The king couldn't believe his eyes. It was magnificent. The old man had fixed it, and he had made it even more special. He had used the crack that ran through the middle of the stone as a stem and carved an intricate, full-blown rose, leaves, and thorns into the diamond. It was exquisite. The king was overjoyed."

What the jeweler had done was to take something flawed and cracked at its heart and turn it into something beautiful. There is a lesson in this story for each of us. Death leaves a wound, much like the crack in the diamond. After our twin loss, we can't comprehend that a new life, not better, but different, can be carved out by us. But what often appears to be flawed and cracked holds value beyond words. When we grieve, we are the gifted craftsman. With time, patience and encouragement, a rosebud can grow from the deepest crack.

Twinless Twins Support Group International can help make that possible. Making twin connections with other twins at our regional meetings, our national conferences (virtual and in person), and on Facebook can be a way of transforming our hurt and sorrow into something beautiful and worthwhile. We listen, we share and we find hope. And in time, we reach out in compassion to others who are on their journey of grief.

I started thinking that celebrating birthdays were going to be a lot

Over the last years since losing Joan, I had some health issues arise. My twin sister showed so much strength and love throughout her illness. Her positive attitude was a guiding light on making the most of her days here on earth. She has taught me that there is nothing that cannot be achieved as long as you have a great love of life with gratitude, faith, love, hope and understanding. Thank you for all of your twinship and love. It has made my grief journey so much easier. I cherish all of the twin friends I have made. You are family and I love you all.



TRIBUTE TO PATRICIA

I first heard about Patricia Freitas when I was in New York, November 2014. Twins, from the United States, emailed me to ask if I would support a twin in Portugal, as she'd lost her twin and had no support there. I immediately said yes and contacted Patricia. We sent long emails to each other over the next ten days and found we had so much in common. Patricia was single and

had lived and worked with her twin Susana. They were top freelance translators and lived at home with their parents in Lisbon. Her life and work had been shattered by the sudden loss of Susana, who had a rare form of endocrine cancer. Like me, Patricia carried on with her translation work, on her own as she saw it as a way of honoring her twin. I had done the same with my and my twin's tutoring business.

Patricia and I stayed in close contact and a day never went past without a good morning email and a good night wish. Sometimes we'd exchange up to 20 quick email exchanges in a day. Patricia and I spoke the same language and she had no twin support where she lived. She had an older brother and elderly parents. Although I had already lost both my parents prior to the loss of my twin Margaret, I too have an older brother.

In June 2015 I went to see Patricia for five days in Portugal and had the honor of meeting her and her parents in person and also see the beautiful city of Lisbon. Patricia loved London as she had visited

there with her twin, shortly before she lost her. She was also intensely interested in yoga and went to Yoga conventions in London and other European cities. I met her near the London Eye once and she took the most amazing photos, as that was her other talent.

The years ticked by and Patricia slowly adjusted to her twin loss. We supported each other through lockdown, which she was so concerned about as she had older vulnerable parents. Her health was an ongoing problem as she had thyroid issues, but she never stopped smiling, working, and attending Lone Twin Network (LTN) Zoom meetings; which she was so delighted to be able to do. Early in 2021, I introduced Patricia to two twins from Great Britain and we set up a weekly Zoom meeting. Fran and Sarah were so supportive. Sarah had lost her twin Caz only two years ago from ovarian cancer. Fran and I had supported Sarah before her loss, which was unusual but so special.

In February 2021, Patricia was diagnosed with a benign ovarian cyst and was due to have surgery, but her health took a sudden

dive and she was finally diagnosed with ovarian cancer on May 8, 2021, which happens to be the anniversary of my mother's death. Patricia had a course of intensive chemotherapy but sadly her fragile body couldn't withstand the treatment. Sarah knew how serious the situation must be and forewarned Fran and me. The last email I sent to Patricia was on Thursday, August 12th. I asked her if she was ok, after her hospital check-up the day before. She sadly said no but she'd try and email the next day. That was the last I heard until her



brother Paulo posted on Patricia's Facebook page about the sad loss of his sister on August 16th. Fran saw the post just after midnight and messaged Sarah and me. I woke up to the devastating news on Tuesday morning at 6:00 am.

We don't expect to lose our twin pals and the loss of the second twin is unthinkable, as we've already had the huge loss of our own twin. Patricia was never my twin and I was never

hers, but I invested heavily in our friendship and we had a very special bond. I'm lucky as I have other strong twin pals and they are supporting me now but I still am left with an actual physical pain over the loss of Patricia. She loved all things Disney and she was always sending me Mickey Mouse gifs. The last one she sent was a week last Tuesday when she heard she was in the final of a top Translation competition. I'm so pleased she knew about that. These days, it is the silence I'm finding difficult.

I was introduced to Patricia in early 2021 through our mutual friend Janet who had asked myself and Fran, another very good friend from the Lone Twin Network (LTN), to befriend a lone twin living in Portugal via our weekly zoom meetings during the long winter covid lockdown. We were of course very happy to welcome Patricia into our little friendship group

which first began years ago in 2012 when my identical twin sister Caz had been diagnosed with terminal ovarian cancer. Our twin friendship has grown from strength to strength over the years with meet-ups, outings for coffee and cake, and mini-breaks together (except during Covid). It was particularly comforting to have Janet and Fran for support when Caz finally lost her battle with cancer in Dec 2018 aged just 53. Before, during, and after Caz's passing our little group has evolved to become an amazing

source of happiness and support as we moved forward in life together.

From the moment I met Patricia and heard her story of losing her twin Susana, I felt an immediate connection with her. She was a very gentle, quiet person with an enormous heart whom I liked immediately. She was also extremely intelligent and I was always in awe of her ability to speak a number of different languages fluently being a professional translator. Patricia was always very hard working and possessed an admirable work ethic being totally committed to her clients and her work. She was equally devoted to her family.

It is tragically sad that Patricia's parents have lost both their

twin daughters within seven years of each other. It is truly heartbreaking. Although I didn't get the opportunity to meet Patricia in person, I feel very privileged to have known such a wonderful, kind, gifted, and compassionate twin. Her premature death at such a young age has been a great shock to us all. It is no understatement to say that we will miss her hugely. May she rest in peace now reunited with her beloved twin Susana, two soul sisters now together forever.



As outlined in several documents created by the TTSGI Board to administer the Endowment Fund, the TTSGI Founders' Memorial Endowment Fund creates a permanent sustaining source of financial support for TTSGI; provides stability for the organization into the future; augments the funds available for scholarships



organization and realize its vision as articulated in the strategic plan; provides a mechanism to attract major gifts to the organization; honors some of the organization's earliest and most generous donors and their twins; and creates a special legacy for twin donors to honor their twins.

WHAT CAN THE ENDOWMENT FUND **INCOME BE USED FOR?**

The Board can spend income from the Endowment Fund to support one or

more of three purposes:

- 1. Special Board Initiatives to enhance TTSGI as the leading resource for information, communication, support, and personal connection for Twinless Twins;
- 2. Scholarship funding for the Annual Conference; or 3. Specific projects identified in the TTSGI Strategic Plan.

WHO CONTROLS THE SPENDING OF THE ENDOWMENT **FUND INCOME?**

The Board President must recommend and the Board must approve through a supermajority the use of all funds coming from the Endowment Fund. The Board Treasurer will be responsible for tracking and annually reporting to the Board and the membership the assets, income, and use of any funds generated by the Endowment Fund, which must always be kept, for accounting purposes, as a separate, permanent fund within the organization.

ENDOWMENT FUND DONORS:

Initial donors to the Endowment Fund must pledge a minimum of \$5,000.00, payable in full or up to three (3) installments, by December 31, 2023. These donors will be considered, in perpetuity, the "Founding Donors" of the Endowment Fund. After January 1, 2024, donors who make at least a \$5,000.00 minimum contribution to the Endowment Fund, payable in full or over a maximum three-year period, will be known as "Sustaining

Donors." No further gifts will be necessary for donors to be forever named "Founding Donors" or "Sustaining Donors" to the Endowment Fund. Each donor signs a Donor Pledge Form for Twinless Twins, Inc., regarding their gift to the Endowment Fund, including those who choose to give their entire gift in one year and those

Q&A FOR THE TTSGI FOUNDERS' MEMORIAL ENDOWMENT FUND

WHAT IS THE TWINLESS TWINS SUPPORT GROUP INTERNATIONAL FOUNDERS' MEMORIAL ENDOWMENT FUND?

The TTSGI Founders' Memorial Endowment Fund, (hereinafter referred to as "Endowment Fund"), has been established with the 2019 gift of \$100,000.00 by Mary R. Morgan. The Endowment Fund was created to provide TTSGI with a permanent sustaining source of financial support; to provide stability for the organization into the future; to augment the funds available for scholarships to attend the TTSGI Annual Conference; to enable the Board of Directors (hereinafter referred to as the "Board") to undertake special initiatives to strengthen the organization and realize its vision as articulated in its strategic plan; to provide a mechanism to attract major gifts to the organization; to honor some of the organization's earliest and most generous donors and their twins; and to create a special legacy for twin donors to honor their twins.

The establishment of the Endowment Fund is a key action item of the organization's Strategic Plan, falling under the strategic goal of strengthening the health of TTSGI by augmenting funds through charitable contributions.

WHAT ARE THE PURPOSES FOR WHICH THE ENDOWMENT FUND INCOME CAN BE SPENT?

- Special Board Initiatives to enhance TTSGI as the leading resource for information, communication, support, and personal connection for Twinless Twins;
- 2. Scholarship funding for the Annual Conference;
- 3. Projects that help carry out the TTSGI Strategic Plan.

WHO CONTROLS THE SPENDING OF THE ENDOWMENT FUND INCOME?

The Board President must recommend and the Board must approve through a supermajority the use of all funds coming from the Endowment Fund. The Board Treasurer will be responsible for tracking and annually reporting to the Board and the membership the assets, income, and use of any funds generated by the Endowment Fund, which must always be kept, for accounting purposes, as a separate, permanent fund within the organization.

HOW CAN I BECOME A DONOR TO THE ENDOWMENT FUND?

Initial donors to the Endowment Fund must pledge a minimum of \$5,000.00, payable in full or up to three (3) installments, by December 31, 2023. Such donors will be considered, in perpetuity, the "Founding Donors" to the Endowment Fund. After January 1, 2024, donors who make at least a \$5,000.00 minimum contribution to the Endowment Fund, payable in full or over a maximum three-year period, will be known as "Sustaining Donors." No further gifts will be necessary for donors to be forever named "Founding Donors" or "Sustaining Donors" to the Endowment Fund. Donors also may represent multiple members of the family/friends of a deceased twin who have pooled their resources together into a single donor unit such as the

"Family" of (the name of the deceased twin).

HOW CAN I FIND OUT MORE INFORMATION ABOUT BECOMING A DONOR TO THE ENDOWMENT FUND?

ARE ALL DONORS TO THE ENDOWMENT FUND REQUIRED TO SIGN THE DONOR PLEDGE FORM?

Yes. For accounting and record-keeping purposes, everyone who wishes to donate to the Endowment Fund must sign the Donor Pledge Form that will be kept on file with both the Executive Director (Michelle Getchell) and the Fundraising Committee Chair (Margaret Daffin).

WHATISTHE ANNUAL PAYOUT FROM THE ENDOWMENT FUND?

After the Endowment Fund is announced to the entire TTSGI membership, and if the total Endowment Fund (exclusive of any pledged funds) exceeds \$200,000.00 (or a larger amount if the Board should so determine), the Board Treasurer will announce to the Board, on an annual basis, how much of the income generated by the Endowment Fund's investments can be spent during the following calendar year (the annual payout). If the income in any given year is not spent, that income can be added to income to be spent in following years.

The Treasurer will be responsible for tracking both the principle and the income generated by the Endowment Fund year by year. As with many Endowments for non-profit organizations, the "payout" does not necessarily need to equate to the exact income generated by the Endowment Fund since the Board may decide instead on a specific PERCENTAGE (for example, 4% or 5% of the principle) as an alternate way to establish an annual payout that would reflect both the income and the fund's annual appreciation due to investments. This approach also takes into account the volatility that can occur due to the market fluctuations through time.

At no time, except under "Exceptions in Times of Emergency" as described below, can funds be spent that would bring the bottom line of the Endowment Fund below \$200,000.00 (or a larger amount if the Board should so determine).

CAN THE ENDOWMENT FUND PRINCIPLE EVER BE SPENT IN ADDITION TO THE ANNUAL INCOME IT GENERATES?

In general, the answer is NO, except where the organization's existence is threatened. Although the Board cannot anticipate a national or organizational emergency that might threaten the existence or operational viability of TTSGI, these guidelines allow the Board to declare that such a situation exists for TTSGI. The declaration of a "viability emergency" would enable the

Board to approve, with a super majority and on a one-time basis only, the spending of a portion of the Endowment Fund principle that might bring the total Endowment Fund below \$200,000.00 (or a larger amount if the Board should so determine.) It is expected that once the emergency situation has been ameliorated, the Endowment Fund would be built back up to its previous level.

HOW WILLTTSGIINVEST THE FUNDS IN THE ENDOWMENT FUND?

Under the leadership of the Board Treasurer, and in consultation with the Finance and Audit Committee, an investment policy has been developed that will be voted on by the full Board. The Finance and Audit Committee also selected an investment firm (Vanguard) to assist with the investment and reporting needs of the Endowment Fund.

HOW WILL THE BOARD REPORT INFORMATION ABOUT THE **ENDOWMENT FUND TO THE MEMBERSHIP?**

The Board Treasurer will include in the TTSGI Annual Report the financial performance of the Endowment Fund, what monies were used and for what purposes, and any accomplishments or results that came from spending income generated by the Endowment Fund. This information will be shared with the membership at the Annual Conference Business Meeting.

WHO ARE THE FOUNDING AND SUSTAINING DONORS TO THE ENDOWMENT FUND?

The initial donors to the Endowment Fund must pledge a minimum of \$5,000.00, payable in full or up to three (3) installments, by December 31, 2023. Such donors will be considered, in perpetuity, the "Founding Donors" to the Endowment Fund. After January 1, 2024, donors who make at least a \$5,000.00 minimum contribution, payable in full or over a maximum three-year period, to the Endowment Fund will be known as "Sustaining Donors." No further gifts will be necessary for donors to be forever named "Founding Donors" or "Sustaining Donors" to the Endowment Fund. There is no end date for donors to become Sustaining Donors.

HOW WILL DONORS BE RECOGNIZED?

The Endowment Fund will be recognized and described, as appropriate, in outreach materials that publicize the existence of TTSGI; in the TTSGI Annual Conference Program where the donors' names and the names of their twins will be printed; on the TTSGI Website; and in one quarterly issue of the Twinless Times, where the Endowment Fund will be described and all of its current donors' names and the names of their twins will appear. When the listing of the Endowment Fund donors is printed, the "Founding Donors" will be listed alongside the names of their twins, followed by the "Sustaining Donors" alongside the names of their twins.

HOW WILL THE FULL MEMBERSHIP LEARN ABOUT THE **ENDOWMENT FUND?**

The public announcement of the Endowment Fund was

made at the 2021 Virtual Annual Conference. The inclusion in this newsletter is another aspect of the "roll out" of the Endowment Fund initiative so that all members and friends of TTSGI will have the opportunity to participate and become "Founding Donors" to the Endowment Fund.

WHERE SHOULD PLEDGED GIFTS TO THE ENDOWMENT **FUND BE SENT?**

The Executive Director will receive all gifts to the Endowment Fund by checks made out to Twinless Twins, Inc., and sent to the following address:

The Board Treasurer will determine how these checks will be handled and deposited. Other forms of donation (stock gifts, matching gifts, Paypal, etc) are possible, but should be discussed with the Executive Director in advance of the gift.

WHO IS IN CHARGE OF ACKNOWLEDGING **ENDOWMENT FUND GIFTS?**

The Board President, Past Board President, and Board Treasurer must approve all documents as well as the mechanism for tracking and acknowledging all gifts to the Endowment Fund. Margaret Daffin, Fundraising Committee Chair, will draft the official letters of thanks to the donors to the Endowment Fund from the organization. In addition, the Board President will write a hand-written note to each donor to the Endowment Fund when the first payment pledged has been received by TTSGI.

WHAT HAPPENS TO THE ENDOWMENT FUND IF TTSGI **CEASES TO EXIST?**

The Endowment Fund Guidelines specify that should TTSGI as an organization dissolve or merge with another organization, the Board would decide on the disposition of the Endowment Fund. In this regard, the Board might identify other 501(c)3 organizations such as Compassionate Friends that provide support for those in grief, or provide support to twinless twins, including parents of multiples. Other possible organizations to receive a portion of the Endowment Fund could include research institutions or centers that support research into twins and other multiple births.

In establishing the Endowment Fund, the Board assumes the responsibility of ensuring the long-lasting impact of the Endowment Fund, whether it continues under Twinless Twins. Inc., or under another similar organization should TTSGI ever merge with another organization or cease to exist.



By Raymond W. Brandt, PhD



By Mary Rockefeller Morgan



By Betty Jean Case


