# **THE EMPTY CHAIR**

### FINDING MEANING AS YOU MOVE FORWARD WITH YOUR LIFE

What's next? Where do I go from here? It may be difficult to envision, but it is possible to move forward and find meaning in your life after the death of your twin. If you only look in the rearview mirror, you won't

be able to go forward. It's a process. Yes, there will be challenges. Grieving is unpredictable, but don't be discouraged if your progress isn't as good as you would like it to be right now.

How do you find meaning out of your life going forward? David Kessler, author of *Finding Meaning*, has spent many decades working with people in grief. In his book he says, "We must be the architects of our lives after loss... our heart may be devastated. It may feel like your loved one was the only thing that gave your life meaning. But that meaning lives within you and is always possible to find again."

"Meaning is a reflection of the love we have for those we have lost... Ultimately, meaning comes through finding a way to sustain your love for the person after their death while you're moving forward with your life", says David Kessler.

What will "meaning" look like for you after the loss of your twin? Meaning is very personal and it takes time to find it. Kessler notes, "Even when you find meaning, you won't feel it was worth the cost of what you lost." Below are a few examples of how others in grief have found meaning in their lives:

Found gratitude for the time they had with their loved one. (No, it is never enough time.)

Experienced how precious life is and valued their life every day.

Found gratitude for the support others gave them and gave back that support to others when they were ready. "Healing through helping others."

Showed love for those still in their lives and made the most of those relationships.

Volunteered in their loved one's name.

Created a project to honor their loved one.

Made a change in their life to honor their loved one. (On a personal note, when Jim died in 1991, I found Twinless Twins and attended my first national conference in 1999. After that conference, my life was never the same. In the years that followed, I have been honoring Jim's life and finding "meaning" through the work I do for others in grief.)

Since meaning is very personal, you may be able to think of other ideas that are meaningful to you.

What are you going to do with the years that follow your twin's death? How are you making the last chapters of your life meaningful? At the end of *Finding Meaning*, David Kessler says, "You have most likely struggled with the acceptance of your loved one's death. Perhaps it's time for you to move on to the next stage of grief. Find your meaning. Your future is still unwritten."

### **TWIN HUDDLES**

Small is Beautiful

Small is beautiful, when applied to Twin Huddles. What exactly is a twin huddle?? A small local group of twins who meet together informally, to drink coffee, visit art galleries and museums!

My experience of twin huddles so far is that they work and they are a really valuable way of connecting with other lone twins! What is surprising is the depth of conversation which takes place. I've actually learned far more about other twins in a huddle situation than I've ever learned in a formal meeting setting.

Our recent Huddle in Manchester on 21st January 2023 was indeed small, but it was such an enriching experience!

I met Co-organiser Jill Ingham at the Moseley Art Gallery for a pre-huddle coffee. Unfortunately, the fire alarm truncated our chat so we set off to the pre-arranged meeting point at Manchester Piccadilly Station.

Jill then took us on a whistle stop walkabout through the university up to our next venue, the Whitworth Art Gallery, on Oxford Road. I learnt so much! The Engineering building (formerly UMIST) has the most red bricks in the world, (8 million!) and Art Nouveau doors and door handles. Two eminent Russian professors invented graphene at Manchester University and Rolls met Royce at the Midland Hotel. The famous Emmeline Pankhurst Centre is also in the university area.

We arrived at the Whitworth Art Gallery and went straight to the beautiful Cafe in the Trees for lunch. The conversation flowed and time flew, as it usually does when twins connect.

We said our goodbyes and went our separate ways. I felt enriched and informed! Thank you to Jill Ingham for organising the event.

She has roads of pounding print She has the runner's resolve She has the body I envy She knows the recipe to evolve.


She is memory of my memories She is the adventurer in my son She is the ally and quiet accomplice She is the ear when day is done.

As part of implementing this principle, the board also approved forming a Diversity and Inclusion Committee. The purpose of the Diversity and Inclusion Committee is to provide advice to the Board and other committees to ensure that our leadership, programming, meetings, content and operations are equitable and inclusive. The goal of the Diversity and Inclusion Committee activities is to ensure our commitment to provide a safe and welcoming community for all identical and fraternal twinless twins, regardless of when loss occurred, race, ethnicity, age, disability, sexual orientation, gender, gender identity, socioeconomic status, geography, political affiliation or religion.

The Diversity and Inclusion Committee wants to hear from you to assist us with ensuring our commitment to provide a safe and welcoming community for all twins and will be sending out a survey in the coming weeks. Please look for the survey and please take it! Your survey responses are anonymous and we will not use any information provided to identify you.

# **COAL MINER'S DAUGHTER TWINS**

I first met Loretta Lynn when I was a mere six years old (1979). Jessica Beasley and I were cast as Loretta's six-year old twin daughters, Patsy and Peggy, in Coal Miner's Daughter, and our younger brother Bill was cast as Randy Cline (Patsy's son). This was easily one of the most exciting moments of our childhood to get out of school for three days, go stay in a hotel (Days Inn in Dickson, TN), bring our new basset hound pup Pete along for the trip, got to play dressup with some weird clothing combinations (shorts and cowboy boots) and eat catered food. We had no idea who Loretta Lynn was or anything about her story, nor did we have any acting experience (a few local commercials followed, but this was the extent of our acting days). We hadn't a clue who Sissy Spacek or Tommy Lee Jones were (my parents did and were star-struck), but for three days, Loretta welcomed us into her home where our scenes were shot, took care of us like we were her own, as did Patsy and Peggy (who were now 16 or so). Most of those pics are tucked away in a scrapbook Mom has always kept to share with my friends or when she was getting sentimental.

When the movie was released, we gathered in our formal best for the premiere at Cheekwood and were surprised at how well the movie did at the box office. We were also beyond excited that it was nominated for an Academy Award for Best Picture and Sissy won for Best Actress. From then on, our lives would be connected to this icon, this First Lady of Country Music, the Queen, the inspiration. It wasn't until I was a younger adult that I grasped the true influence she has had on many of the musicians I listened to and respected. Decades after the movie was made, Loretta continued to reinvent herself, make new projects, appear in the headlines, and each time, my friends, sorority sisters, and family would reach out to me. Hardly a week goes by that I don't read about, hear, or have someone share something "Loretta" or CMD with me.

Back in 2004, I had a student, Whitney (Goddard) Geitner and her mother Pam Goddard, who turned out to be long time close friends with Loretta. Pam took Jessica Beasley and me to Hurricane Mills again to see the museum, see Loretta perform, reunite with Patsy and Peggy, and tour her home (now a museum). I am thankful for this bond I share with the Goddard family and the stories Pam continues

to share with me about Loretta.

I am thankful for this tiny piece of history I shared with Loretta and the joy this movie seems to give people (it is highly nostalgic for me growing up in Nashville). I'm mostly thankful for the strong, independent woman and role model Loretta was, someone who spoke her mind about things that were important to her, for being a trail blazer for the others who came after her, her (literal) rags to riches story, and for the impact she left on the world. RIP, Loretta.

I wrote this piece on October 4, 2022 as a Facebook post following Loretta's passing. Little did I know that my twin sister Jessica would pass away unexpectedly on Christmas Eve of 2022 at the age of 50, just two and a half months after Loretta. I see things differently now. We had never discussed living life without the other, and why would we?

The past month has been a series of extreme lows but also some beautiful moments of love, compassion, and gratitude. Messages, texts, calls, posts, visits that share the light and love Jess brought into this world and a beautiful celebration of life service for our final goodbyes would soon follow. Of course, the movie was mentioned several times during the service.

She always took such great pride in our roles as the Patsy (me) and Peggy (Jess) Lynn when they were six. As twins, we always got a lot of attention, but, after filming the movie, the attention mounted. From friends, family, strangers, country music fans, Tennesseans, and from any nook and cranny of the country. I was always used to dividing any attention I got with Jess. Now, eyes are on me to see how I will cope with this tragic loss, something so unnatural for any twin to have to do. Jess's line (we each only had one speaking part) in the movie was, "My name ain't twin!" as she spouted to Sissy Spacek as Loretta after coming home from a long road stretch, but Jess was so proud of being a twin... so proud of being in that movie back in 1980, and so proud of our twinship. Until we are reunited in heaven, I expect she's telling everyone up there. even Loretta, that she is a twin, and I'll be doing the same down here. Rest in Peace, my sweet Jess (a.k.a. 6-year old Peggy Lynn).

The year-end Accounting is not quite completed for 2022, but I wanted to provide a snapshot of where we currently stand for 2022 in comparison to 2021.

The Balance Sheet and Income Statement of TTSGI for the year ended December 31, 2022, with a comparison to 2021 are presented. Below are notes of explanation that will clarify items.

**Balance Sheet** - Our main bank accounts had a balance of \$156K, down \$11K from 2021. The decrease is primarily due to Prepayment of expenses for 2023 and 2024 totaling \$13.1K.

Vanguard is our financial advisor for managing the funds from the TTSGI Founders' Memorial Endowment Fund. When twins pledge, then contribute to the Endowment Fund, the monies are deposited into our operational bank account and then transferred to Vanguard. At the end of the year, approximately \$14.3K had not yet been transferred from our operational account into Vanguard. These Vanguard deposits are managed in four funds. These funds pay dividends and are immediately reinvested.

In the Equity section, we have absorbed the prepaid conference registrations for the July 2022 Denver conference. We did not offer prepayment for the 2023 Conference in Cincinnati. The Scholarship Fund represents donations and half (50%) of the Memory Walk donations. These funds are used to assist twins in financial hardship to attend a conference. A board committee reviews each applicant. This fund may also be used for membership fees for those in hardship.

The TTSGI Founders' Memorial Endowment Fund of \$247.5K represents the donations received from twins to the fund and dividends paid by Vanguard. Thanks to the generosity of our twins, this fund has increased by \$32.3K from 2021.

**Income Statement** - Our main sources of operating revenues are the annual conference and its activities, contributions and membership dues. In addition to operating revenues, we receive gifts to the TTSGI Founders' Memorial Endowment Fund and the Scholarship Fund.

In 2022, we returned to an in-person Conference after a two year delay, due to the Covid Pandemic. The conference is the largest source of revenue and the largest cost to TTSGI resulting in a significant increase to income and expenses in 2022 over 2021.

Our contributions increased by \$22.9K due to a significant gift by one donor and a very successful "Double Your Donation" campaign that raised \$18.4K. Our membership dues increased \$2.9K over 2021 due to an increase in paid members. As total income increased by \$59.6K similarly, our expenses also increased by \$49.8K. The most significant change is due to returning to an inperson conference in 2022. We also overhauled our website in 2022 which increased expenses by \$11.6K.

In summary, we ended the year with revenue exceeding expenses and our net income for 2022 was \$20.5K, which was \$9.8K higher than the net income of \$10.7k in 2021.

- Participants should not attend an in-person event if they have any indication of COVID-19 symptoms, test positive for COVID-19, or have been exposed to someone with symptoms or someone suspected or confirmed to have COVID-19.
- By registering for a live, in-person event, you agree to follow all safety protocols requested by the organizer of the event and by the event venue at the time of the event.

These meetings are announced in the Twinless Times, on Facebook, on our Website and through individual email invitations. This is one of the best benefits of your membership in TTSGI as only members can attend these meetings. In this article below, you will find a listing of each of these "affinity groups," along with the date of their next meeting. We also report in the Twinless Times on meetings that have already taken place.

I encourage each of our members to take advantage of these offerings and put at least one of these dates on your calendars now. Every "affinity group" has a host and a facilitator. When you receive the email invitation from the host, all hosts are listed below with their "affinity group," be sure to open the email and respond positively. Once you "sign up for the meeting," you will be contacted through email and given the Zoom link the day before the meeting. There are a few "affinity groups" that are sending the Zoom link in the initial announcement email without requesting an RSVP. We understand that those members who do receive the link in advance are well aware that the link they receive is unique to them and know the importance of not sharing it.


#### **CRITERIA AND DESIRABLE QUALIFICATIONS**

- 1. Must be an active member of TTSGI for at least two years and have a pattern of attendance and giving and is willing to donate their time, talent and/or treasure.
- 2. Must have been a twinless twin for at least two years, who is in a good place in their grief journey and is able to cope effectively with their loss.
- 3. Must demonstrate integrity and ethics and abide by the TTSGI Code of Conduct.
- 4. Able to act with tact and diplomacy in interactions with other twins.
- 5. Able to demonstrate empathy and discernment and able to keep sensitive issues confidential.
- 6. Must have access to and be proficient with technology in order to communicate with Board through emails.
- 7. Must attend the Annual TTSGI Conference at their own expense. All other Board meetings are typically held using an electronic platform.
- 8. Must be willing to participate in administrative duties that may be assigned to them.
- 9. Must be willing to commit to entire Term of Office, which is for three (3) years.

#### PROCESS

- 1. The Nominating Committee will review the recommendations that are received by April 15, 2023, and submit the list to the Board for evaluation.
- 2. The Nominating Committee will review the proposed candidates using the above criteria and other desirable qualifications. They will also consider whether a candidate brings diversity to the board. This will help to ensure an inclusive and welcoming Board of Directors. Factors include geographical location, gender, race, type and age of loss, type of twinship, and other considerations.
- 3. The Committee Chair will then present the slate at the General Business meeting. This meeting will be held during the Annual Conference, on Saturday. There will be no nominations taken from the floor.






### **"LIVING WITHOUT YOUR TWIN"**
